TERMS & CONDITIONS



CONTROLLING PROVISIONS

These terms and conditions shall replace all terms and conditions of Buyer's order and of any proposal or quotation to Buyer not agreed to by Buyer and Seller prior to the date of the invoice.

WARRANTY

Seller warrants as per manufacturer's written manufactured products to the extent that Seller will replace those having defects in material or workmanship when used for the purpose which manufacturer recommends. If Seller's examination shall disclose to its satisfaction that the products are defective, and an adjustment is required, the amount of such adjustment is the net sale price of the defective products only. No allowance will be made for labor or expenses of repairing defective products or damage resulting from the same. Seller warrants the products that it sells of manufacturers to the extent of the warranties of their respective makers. THIS IS SELLER'S SOLE WARRANTY, SELLER MAKES NO OTHER WARRANTY OF ANY KIND, EXPRESS OR IMPLIED; AND ALL IMPLIED WARRANTIES OR MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE WHICH EXCEED SELLER'S AFORESTATED OBLIGATION ARE HEREBY DISCLAIMED BY SELLER AND EXCLUDED FROM THIS WARRANTY. Seller neither assumes, nor authorizes any person to assume for it, any other obligation concerning the sale of the products. This warranty shall not apply to any products or parts of products which (a) have been repaired or altered outside of manufacturer's factory, in any manner; or (b) have been subject to misuse, negligence or accident; or (c) have been used in a manner contrary to manufacturer's instruction or recommendations.

SELLER'S LIABILITY

Seller will not be liable for any loss, damage, cost of repairs, incidental or consequential damages of any kind, whether based upon warranty, contract or negligence, arising in connection with the sale, use, or repair of the products.

PRICING & PRODUCT AVAILABILITY

All orders will be invoiced at the price in effect at the time of shipment. Prices are subject to change without notice. Verbal quotations are subject to immediate acceptance. Freight charges F.O.B. Point-of-Shipment, unless otherwise stated. Items are not necessarily stocked or available for sale at all locations.

INSTALLATION & ALTERATION

No employee of SPS Company, Inc has the authority to suggest or recommend merchandise be installed or altered in any manner other than that shown in Manufacturer's literature or instructions.

RETURNS

Return of any goods, if accepted, is for credit only. Seller cannot accept return of goods unless Seller grants prior permission, in which case it will be credited. Returns are subject to the following: (a) all material returned must, on arrival at Seller's locations, be found to be in salable condition; if not, cost of putting in such condition will be deducted from credit memoranda; (b) a restocking charge will be made from all credit memoranda issued for material returned; (c) transportation charges, if not prepaid, will be deducted from credit memoranda. No credit will be issued after 30 days from date of invoice.

SHIPMENTS

The cost of any special packing or handling caused by Buyer's requirements or requests shall be added to the amount of the order. No claim for shortages will be allowed unless made in writing within ten days of receipt of a shipment. Claims for goods damaged or lost in transit should be made on carrier, as Seller's responsibility ceases on delivery to the carrier. Buyers should examine shipments carefully before accepting delivery from the transportation company.

TAXES

The amount of any sales, excise or other taxes, if any applicable, shall be added to the purchase price and shall be paid by Buyer unless Buyer provides Seller with an exemption certificate acceptable to the taxing authorities.

TERMS OF PAYMENT

Seller reserves the right to extend credit to qualifying Buyers. Please request a Credit Application from an SPS Companies, Inc employee. If credit is extended, the standard terms offer a cash discount. All purchases on or before the last day of each month will be due on the 10th day of the following month. The discount amount available for each invoice is listed on the invoice. If purchases are made by Visa, MasterCard, Discover or American Express the cash discount will not apply.
